2. PROCESSING PURPOSES AND LEGITIMATE BASIS

Your personal data will be processed by OMIE in order to manage your information requests sent through this form or to the email address info@omie.es, being the legitimate basis your consent (article 6.1.a) GDPR), consent that is expressly provided by filling and sending this form or by sending an email to the address info@omie.es.

User will, in all cases, be responsible for the truthfulness, accuracy, validity and authenticity of Personal Data provided. OMIE reserves the right to exclude the registration of any users having provided false data and to seek all remedies available at law and in equity. In case of responsibilities arising from the breach of these conditions, user will respond of the consequences of such breach.

3. STORAGE PERIOD

Personal data will be kept for the time necessary to answer your information request. Once this period has ended, OMIE will keep the personal data duly blocked for a period of 5 years with the sole purpose of addressing any kind of liabilities that may arise or in general terms asserting, exercising or defending legal claims. Once the time limit for exercising legal actions has elapsed, your personal data will be deleted.

4. SECURITY MEASURES

OMIE, will process your personal data under absolute confidentiality. Furthermore, it has implemented adequate technical and organizational measures to guarantee the security of your personal data and to prevent their alteration, loss, misuse, treatment and unauthorized access or theft, taking into account the state of the technology.

5. RECIPIENTS

Right	What does this right consist of?
Right of access	Consult what personal information we have about you
Right of rectification	Modify the personal information we have about you when it is inaccurate
Right to object	Request that we dont process your personal data for certain specific purposes
Right of erasure	Request to delete your personal data
Right of restriction	Request to limit the processing of your personal data
Right to data portability	Obtain in an electronic format the personal data that you have provided us and those that have been generated in the context of the service.
